Sub.: **Bharti Point-to-Point LeasedLine Connectivity in Mumbai/Thane/Vashi**

In terms of provisions of the Rules, Bye-Laws and Regulations of the Exchange the Members of the Exchange are notified as under:

The Exchange is pleased to announce its decision to introduce Point-to-Point Leased Line facility through Bharti. The said facility is available for Mumbai, Thane and Vashi.

Members who are willing to avail this facility are requested to inform their intention in the specified format enclosed as **Annexure A**.

A. An overview of the facility

1. Router Requirement

The members have to procure a dedicated Router directly either from Indian Commodity Exchange or from their own

vendor, which shall have to be installed at their offices for accessing Indian Commodity Exchange trading system. The specifications of the Router are given in **Annexure B** to this circular.

2. Location Feasibility from Bharti

Bharti shall first investigate the member Location feasibility for Point-to-Point leased line and thereafter proceed for commissioning. After feasibility Exchange will inform members of the applicable charges.

3. Payment

The member shall be required to pay a one-time charges and annual recurring charges as below:

i) One Time Charges

The member availing the facility shall be required to pay a one-time charge of Rs. 27575/- (including 10.3% service tax). This cost includes installation of Modem/ MUX for Wireline connectivity

ii) Recurring Annual Charges

Members have to pay in advance, annual recurring charge towards 2mbps bandwidth charges as per their location distance from Indian Commodity Exchange Data Center located in Vikhroli as given below.
