A. An overview of the facility

1. Router Requirement

The members have to procure a dedicated Router directly either from ICEX or from their own vendor, which shall have to be installed at their offices for accessing ICEX trading system. The specifications of the Router are given in Annexure 1.

2. Payment

The member shall be required to pay Charges as following

i) Annual bandwidth Charges

The member availing the facility shall be required to pay Bandwidth Charges as applicable directly to TTSL

ii) Router Charges

Incase Member wants to take router from ICEX, charges as given in Annexure 1 will be applicable
