

## Application of New VSAT Equipment-3 Year payment Option

Indian Commodity Exchange is offering Sky Edge VSAT connectivity to its members.

For a Three year period a member has to pay 155200 including 10.3% service Tax for VSAT Charges This price includes broadcast, interactive bandwidth charges, Site survey, Installation, Transportation, Commissioning of VSAT equipment (ODU, IDU and Antenna), Cost of the IFL cable (30 meters\*2 per site) and Annual maintenance charges for three year period. After a period of 3 years a member has to pay Rs. 24090 including 10.3 % service tax per year for Annual Maintenance changes and annual broadcast and interactive bandwidth charges.
